

# My Lenovo Rewards Thanks a Thousand Sweepstakes

## Official Rules

No purchase is necessary. Void where prohibited.

Entry into this Sweepstakes constitutes your acceptance of these Official Rules.

### 1. Entry dates

The My Lenovo Rewards Thanks a Thousand Sweepstakes (“Sweepstakes”) begins at 10:00 a.m. ET on November 3, 2025, and ends at 11:59 p.m. ET on November 30, 2025 (“Entry Period”).

### 2. Eligibility

The Sweepstakes is open to all registered members of the My Lenovo Rewards program (“My Lenovo Rewards”) who are (i) legal residents of the fifty (50) states of the United States (including District of Columbia) or Canada (excluding Quebec), and (ii) 18 years of age or older, or have otherwise reached the age of majority in the country in which they reside. THIS SWEEPSTAKES IS VOID WHEREVER RESTRICTED BY, WITHOUT LIMITATION, FILING OR REGISTRATION REQUIREMENTS, OR IS OTHERWISE PROHIBITED OR RESTRICTED BY LAW. Individuals employed or contracted by Lenovo (United States) Inc. (“Sponsor”), its parent or affiliated companies, subsidiaries, and/or advertising and promotion agencies (collectively, “Sweepstakes Parties”) at any time during the Entry Period, and members of their immediate family or persons living in the same household, are not eligible.

### 3. How to enter

During the Entry Period, eligible entrants (“Entrants”) may enter and receive one (1) entry to the Sweepstakes by visiting the My\_Lenovo Rewards dashboard located under “My Account” on the Lenovo.com website, and clicking the Sweepstakes tile.

In addition to the required entry method described above, eligible Entrants may earn additional entries into the Sweepstakes as follows:

#### 1. Making a Qualified Purchase:

- Entrants who make a qualifying purchase through their My Lenovo Rewards account during the Entry Period will receive one (1) additional entry per qualifying purchase. Limit of 1 per day.

#### 2. Redeeming Reward Points during a purchase

- Entrants who redeem rewards points toward a purchase during the Entry Period will receive one (1) additional entry per redemption transaction. Limit of 1 per day.

#### 3. Referring a friend to the My\_Lenovo Rewards program

- Entrants who successfully refer a new member who enrolls in the MyLenovo program during the Entry Period will receive one (1) additional entry per successful referral. Limit of 1 per day.

## **Alternative Method of Entry (AMOE):**

To enter the Sweepstakes without taking the above actions, Entrants must be a MyLenovo Rewards member and must fill out this [form](#) with their full name, complete address, and email address. Entrants may obtain one (1) entry per day via this online method. All form entries must be sent during the Entry Period, and received on or before 11:59pm ET on November 30, 2025, to be eligible for the Sweepstakes.

By submitting an entry, each Entrant agrees that his or her entry complies with these Official Rules. Each Entrant also agrees that Sponsor may disqualify the Entrant from the Sweepstakes if Sponsor believes, in its sole and absolute discretion, that Entrant and/or any entry are not compliant with these Official Rules. If Sponsor rejects any reward exchange or entry for any reason, such entry will be disqualified and will not be considered valid. Entries may only be made according to the methods described above. The use of any automated means to enter (including but not limited to the use of any robot, script, macro, or other automated services) is not permitted and any such entries earned will be disqualified. Only eligible entries received by Sweepstakes Parties will be eligible. Illegible, unintelligible, incomplete, or garbled entries will be disqualified.

## **5. Ownership of entries**

By submitting an entry, each Entrant agrees Sponsor shall own the entry submitted (including all copyrights thereto and all rights embodied therein) and that it and its designees may exploit, edit, publish, use, adapt, modify, copy, disseminate, or dispose of any entry, the concepts embodied therein or any elements thereof, online, in print, film, television, or in any other media for advertising and promotional purposes without compensation or notification to the Entrant of any kind, except as prohibited by law.

## **6. How to win**

At 11:59 p.m. ET on November 30, 2025, the Entry Period will be closed in its entirety. On or about December 5, 2025, two (2) winning Entrants will be randomly selected from the pool of eligible entries received during the Entry Period to receive the prize specified below. Winner will be notified by Sponsor via email. Note: You are not a winner of any prize until you have been verified as a winner by the Sponsor. Decisions of the Sponsor are final in all matters relating to this Sweepstakes. The odds of winning depend on the number of eligible entries received.

## **7. Prizes**

There will be a total of two (2) winners during the Sweepstakes, who will each receive 1,000,000 My Lenovo Rewards points added to their My Lenovo Rewards accounts (ARV \$1,000) to use toward the purchase of Lenovo products via the [Lenovo.com](http://Lenovo.com) website.

The total ARV of all prizes in the Giveaway is \$2,000.00 USD. Only the prizes and the prize components specified in the numbers indicated will be awarded. Prizes are non-transferable, with no cash redemption or equivalent. Sponsor reserves the right to substitute a prize or prize component of equal or greater value should a prize or any component of a prize become unavailable. Except as specifically provided herein, prize packages do not include insurance, personal expenses, incidental charges, gratuities, or any other items not specifically described in these Official Rules. All applicable taxes and usage charges on prizes are the sole responsibility of the winner. If required by law, Sponsor or its agents shall require payment from the winner of taxes to be remitted to the appropriate taxing authorities. On or about December 5th, 2025, the potential prize winners will be notified by Sponsor via email. The potential winners may be asked to verify eligibility and sign a Release & Waiver of Liability. Additionally, if a winning Entrant is a resident of Canada, to be declared a winner, selected Entrant may also be required to provide the correct answer to a mathematical skill-testing question administrated by email or posed by telephone at a mutually convenient time. Verification must be completed within forty-eight (48) hours of the potential winner notification. Failure to verify eligibility may result in disqualification and an alternative potential winner may be selected. ## **11. Arbitration and choice of law**

Except where prohibited by law, as a condition of participating in this Sweepstakes, Entrant agrees that (i) any and all disputes and causes of action arising out of or connected with this Sweepstakes, or any prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding confidential arbitration under the rules of the American Arbitration Association and held at the AAA regional office nearest the Entrant; (ii) the U.S. Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (iii) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to claim, punitive, incidental, or consequential damages, or any other damages, including attorneys' fees, other than Entrant's actual out-of-pocket expenses (i.e., costs associated with entering this Sweepstakes), and Entrant further waives all rights to have damages multiplied or increased. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of Entrants and Sponsor in connection with this Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the State of New York without regard to choice of law rules.

Upon filing a demand for arbitration, all parties to the arbitration will have the right of discovery, which discovery shall be completed within sixty days after the demand for arbitration is made, unless further extended by mutual agreement of the parties.
