

My Lenovo Rewards Ultimate Setup Sweepstakes

OFFICIAL RULES

July 2026

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. Entry into the My Lenovo Rewards Ultimate Setup Sweepstakes ("Sweepstakes") constitutes your acceptance of these Official Rules.

DATES: This Sweepstakes will be open from July 20, 2026 at 12:00am EST until August 16, 2026 at 11:59pm EST (collectively, the "Entry Period.")

WHO MAY ENTER: Open to all registered members of My Lenovo Rewards ("MLR") who are (i) legal residents of the fifty (50) states of the United States and the District of Columbia, and (ii) 18 years of age or older. Eligible individuals who are not already MLR members may sign up for MLR membership to enter. THIS SWEEPSTAKES IS VOID WHEREVER RESTRICTED BY, WITHOUT LIMITATION, FILING OR REGISTRATION REQUIREMENTS, OR IS OTHERWISE PROHIBITED OR RESTRICTED BY LAW. Individuals employed by Lenovo (United States) Inc. ("Sponsor"), or its parent and affiliated companies, subsidiaries, and/or advertising and promotion agencies (collectively, "Sweepstakes Parties") at any time during the Entry Period, and members of their immediate family or persons living in the same household, are not eligible.

HOW TO ENTER: During the Entry Period, eligible entrants ("Entrants") can enter the Sweepstakes by (a) visiting the My Lenovo Rewards dashboard located under "My Account" on the Lenovo.com website, and (b) exchanging 1,000 of Entrant's available rewards points for one (1) entry into the Sweepstakes. Entrants may exchange up to 10,000 points per calendar day during the Entry Period, resulting in up to ten (10) entries into the Sweepstakes per day (1,000 rewards points per entry). All eligible entries received during the Entry Period will be entered. Entries in excess of this limit will be disqualified. ALTERNATE METHOD OF ENTRY ("AMOE"): To enter Sweepstakes without taking the above actions, Entrants must be My Lenovo Rewards Members and must fill out a form with their full name, complete address, email address and date of birth to this [FORM](#). Members may submit the AMOE form up to ten (10) times per calendar day during the Entry Period. All form entries must be sent during the Entry Period, and received on or before August 16, 2026.

Entries may not be sexually explicit or suggestive; unnecessarily violent; derogatory of any ethnicity, race, gender, religion, sexual preference, disability or age group; or profane or pornographic. Additionally, entries may not defame, misrepresent or contain disparaging or libelous remarks about Sponsor (or its products or services), or other people and/or companies; contain any offensive or vulgar language; or depict any pornographic or illegal act. Any entries containing such subject matter or any other

inappropriate content, as determined by Sponsor in its sole and absolute discretion, will be considered ineligible and will not be part of the Sweepstakes.
