

## **Motorola Survey 2026 – Terms & conditions**

**Effective Date:** July 31<sup>st</sup> 2026

**Promoters:** Lenovo International Coöperatief U.A. with registered office at De Entree 250 A, 1101 EE Amsterdam, Netherlands (hereinafter: “Motorola”).

### **1. Eligibility**

This prize draw ("Promotion") is open to residents of the following countries:

Austria, Belgium, Denmark, Finland, France, Germany, Ireland, Italy, Netherlands, Norway, Spain, Sweden, Switzerland and the United Kingdom.

Participants must:

- Be aged 18 years or over (or the age of majority in their country of residence).
- Be legal residents of one of the participating countries.
- Be eligible to travel to Spain.
- Employees of the Promoters, Lenovo Group companies, their agencies, affiliates and immediate family members are not eligible to participate.

### **2. Promotion Period**

The Promotion begins on **August 17 at 10 am CET** and closes on **September 2 at 11:59 PM CET** ("Promotion Period").

Entries submitted outside the Promotion Period will not be accepted.

### **3. How to Enter**

During the Promotion Period, eligible participants must:

1. Visit the official Motorola campaign landing page.
2. Complete the survey.
3. Provide the required contact information.
4. Accept these Official Rules and Motorola's Privacy Policy.
5. Submit the completed survey.

Upon completion of the survey, participants will:

- Receive a personalized Motorola smartphone recommendation.
- Receive an exclusive discount code applicable to their recommended device (where available in their country).
- Be automatically entered into the prize draw for a chance to win the Prize described below.

No purchase is necessary to enter the prize draw unless required by local law.

Only one (1) entry per person/email address will be accepted during the Promotion Period.

#### **4. Winner Selection**

Following the random draw, Motorola or its appointed agency will match the selected unique identifier to the corresponding participant for the sole purpose of verifying eligibility and notifying the winner.

One (1) winner will receive:
